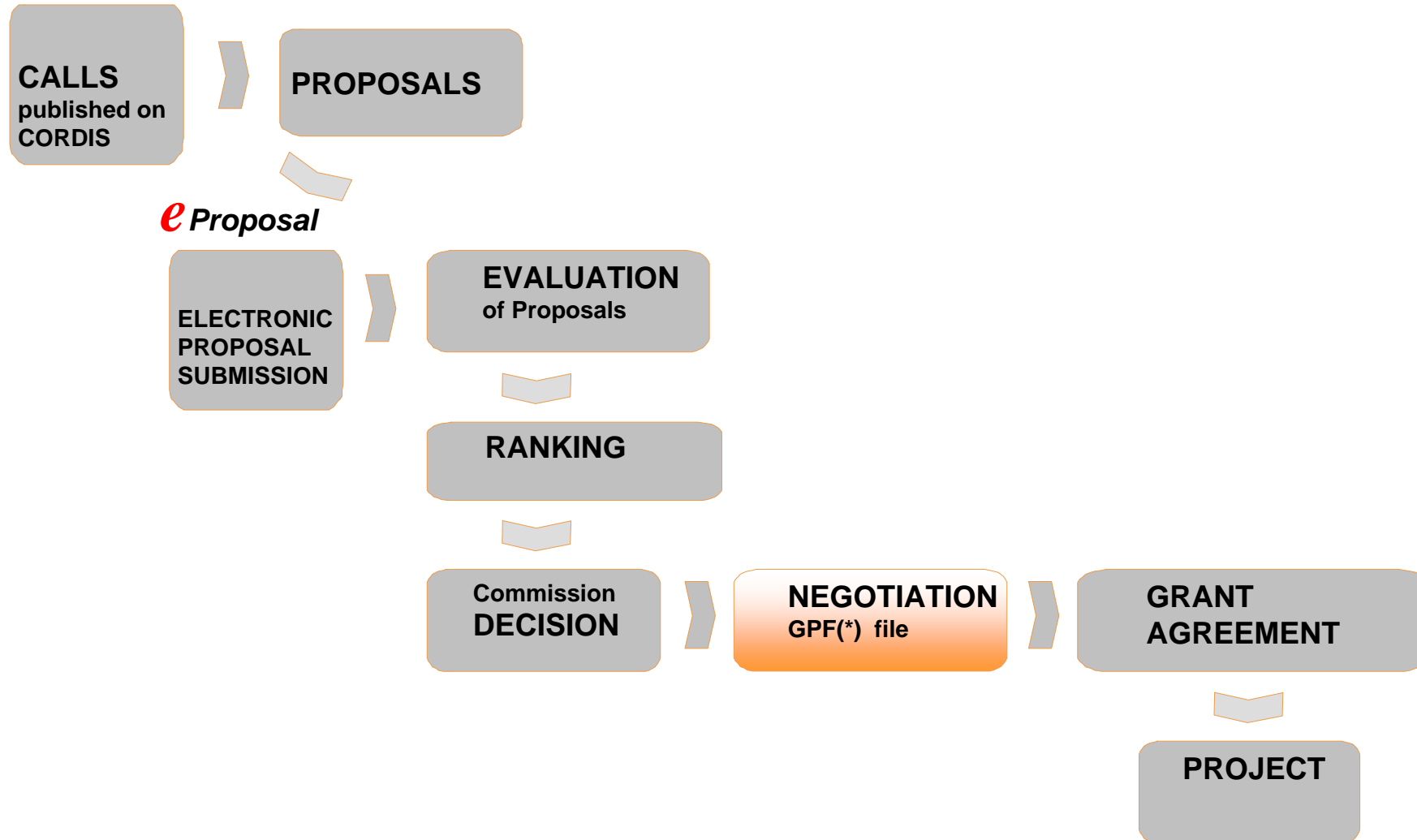

NEF

The negotiation process allows the exchange of information between EC Officers and the external Coordinator of the Project.

NEF (Negotiation Forms) is the Web application that has to be used to collect information and to complete the **GPF (Grant Agreement Preparation form)** file.

The Coordinator inserts legal, financial and other background information in the GPF using NEF.

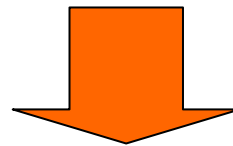
